#### PRIVACY POLICY AGREEMENT

# Why We Collect Information and For How Long

We are collecting your data for several reasons:

- To better understand your needs and provide you with the services you have requested;
- To fulfill our legitimate interest in improving our services and products;
- To send you promotional emails containing information we think you may like when we have your consent to do so:
- To contact you to fill out surveys or participate in other types of market research, when we have your consent to do so;

The data we collect from you will be stored for no longer than necessary. The length of time we retain said information will be determined based upon the following criteria.

- The length of time your personal information remains relevant;

- Any retention periods prescribed by law or recommended by regulators, professional bodies or associations.
- The type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

#### **Use of Information Collected**

HomeSharing, Inc. does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties. HomeSharing, Inc. may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from <a href="www.homesharing.org">www.homesharing.org</a>.

HomeSharing, Inc. may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

HomeSharing, Inc. may feel it necessary, from time to time, to contact you on behalf of our other external business partners with regards to a potential new offer which may be of interest to you. If you consent or show interest in presented offers, then, at that time, specific identifiable information, such as name, email address and/or telephone number, may be shared with the third party.

HomeSharing, Inc. may find it beneficial to all our customers to share specific data with our trusted partners in an effort to conduct statistical analysis, provide you with email and/or postal mail, deliver support and/or arrange for deliveries to be made. Those third parties shall be strictly prohibited from making use of your personal information, other than to deliver those services which you requested, and as such they are required, in accordance with this agreement, to maintain the strictest of confidentiality with regards to all your information.

HomeSharing, Inc. uses various third-party social media features including but not limited to Facebook, LinkedIn, TicketLeap, Instagram, PayPal, GoFundMe and other interactive programs. These may collect your IP address and require cookies to work properly. These services are governed by the privacy policies of the providers and are not within HomeSharing Inc.'s control.

#### Disclosure of Information

HomeSharing Inc. may not use or disclose the information provided by you except under the following circumstances:

- As necessary to provide services or products you have ordered;
- In other ways described in this Policy or to which you have otherwise consented;
- In the aggregate with other information in such a way so that your identity cannot reasonably be determined;
- As required by law, or in response to a subpoena or search warrant;

- To outside auditors who have agreed to keep the information confidential;
- As necessary to enforce the Terms of Service;
- As necessary to maintain, safeguard and preserve all the rights and property of HomeSharing, Inc.

HomeSharing, Inc. greatly respects your privacy. # **Notice to European Union Users**
