



# Building Bonds and Changing Lives: Hakim and Gerard's HomeSharing Journey

rovider Hakim was referred to the HomeSharing by one of our current providers. Initially, he was unsure about participating due to his disability and homeownership status. He also felt hesitant since he had no family in the area and wanted to understand more about HomeSharing before making a decision.

To address his concerns, I scheduled a one-on-one inperson intake meeting with him. During our conversation, Hakim became more confident as I explained how HomeSharing works. He shared that he had been paralyzed due to a major stroke and was looking for companionship at home. When I informed him that HomeSharing could help him find a compatible match for companionship, he expressed great interest in becoming a Provider.

We proceeded with the intake, application, and interview processes. After carefully reviewing his request, I was able to find a suitable match for him. His new companion, Gerard, was thrilled about the opportunity.

Seeker Gerard Davies, originally from Seaside Heights, is a retired, wheelchair-bound, disabled widower and father who was searching for affordable housing. Facing the challenges of being both disabled and retired, Gerard hoped his family would assist him. At the time, he was living in an apartment in Seaside Heights with his daughter; however, their relationship had begun to drift apart, leaving him feeling worried and uncertain about his living situation.

Gerard learned about HomeSharing through the Ocean County Board of Social Services, but initially felt apprehensive about reaching out to us. Encouraged by the information he was provided, he eventually contacted HomeSharing, where I explained the program's process. As the conversation progressed, Gerard became noticeably more at ease and comfortable with completing the intake process.

I provided him with comprehensive information about HomeSharing, and guided him through the intake and application process. Throughout December, we diligently worked through the application, background check, and intake procedures to find him a suitable match. During his



interview, I conducted a thorough assessment and identified a match that aligned with his preferences—someone who was also disabled, as he had requested.

Gerard connected with his match, Hakeem from Neptune, and after an initial coffee meeting, they bonded instantly. Gerard had specifically requested a placement in Neptune to remain close to his doctor and essential resources in Monmouth County.

When we conducted the match meeting, I observed a smooth and seamless transition between both parties and HomeSharing. The joy they shared was evident, and both expressed immense gratitude for being brought together. Ultimately, they successfully moved in together.

The match is successful, and both Hakim and Gerard are happy together. Both clients are overjoyed with the support HomeSharing provides to them, and grateful for the positive change it brought to their lives.

# **HomeSharing Veterans Pilot Initiative**

omeSharing is proud to announce a new partnership with the Northfield Bank Foundation, whose generous support is funding our new Veterans Pilot Initiative.

Recognizing the unique challenges faced by veterans—particularly as they age — HomeSharing has identified this group as a priority population in need of housing stability, support services, and social connection. Through this initiative, we are committed to helping veterans age in place or, when facing housing insecurity, find safe and supportive shared living arrangements with fellow veterans.

The program's primary goal is to establish a veteran-toveteran matching system that promotes stable housing, enhances financial security, fosters companionship among those with shared life experiences, and connects participants with essential community resources.

The HomeSharing Veterans Pilot Initiative will focus on serving veterans in Central and Northern New Jersey. In collaboration with veterans organizations such as the VFW, the American Legion, and local Veterans Affairs facilities, we aim to reach those who are precariously housed or socially isolated.

We anticipate launching the initiative in May 2025 with the hiring of a part-time social worker to lead this important work. Executive Director Steven Nagel is joined by provider Fran M. and Diane Senerchia, Executive Director of the Northfield Bank Foundation, at Fran's home to present the funding for the Veteran's Initiative.
